	Infrastructure Levy which is paid on development within the parish. CIL is over and above the precept
	figure and amounts to £24,243 which can be spent on projects within the parish. The budget also
	allows for a General reserve fund of £24,485.
	Currently Parish and Town council precept levels are not capped by Central Government, but this
	could change at a future date, or with a future government. It was also noted that Unitary Authority
	council tax is likely to increase.
	The Working Party recommended an increase in precept of £570 which represented +1% increase over
	last year.
	This recommendation to be approved at the December parish council meeting to allow Councillors and
	members of the public to consider it. This will represent an extra £1.14 per year on the Council tax
	bill of a family living in a Band D property.
