12.1	Barby Village Hall AGM Tues 22 March at 7pm. Councillor Paul Reynolds attended the AGM and said there was no major issues to report. The Clerk was asked to investigate free Gigaclear wifi for the Village hall.
12.2	West Northamptonshire Consultation - Public Spaces Protection Order Consultation: Responsible ownership of dogs and prohibition of smoking in certain places see West Northamptonshire Consultation Hub this was noted.
13	HIGHWAYS
13.1	SPEEDWATCH Sat 5 th March 22 until the morning of Sat 2 nd April 22. Councillor Gove gave a report to the Council. 93 recorded speeding events were logged and letters sent to offenders.
13.2	Flooding of sewerage on Rugby Road. Severn Trent have agreed to investigate the blockage further.
13.3	Electric Vehicle Charging Points in Barby and Onley were discussed. "Zest" has been granted £M from Government to provide community charging points. This is fully funded and Zest will upgrade and maintain the equipment over a 15 year period. A 15 year lease is required for installation points. On-Street Residential Chargepoint Scheme guidance for local authorities - GOV.UK (www.gov.uk) Councillor Cotton agreed to send photos of potential sites at Onley Park to Cllr Reynolds. Cllr Reynolds reported that Barby Village Hall are prepared to consider siting charging points in the car park. Overnight charging can be sourced from a street light.
13.4	It was agreed to investigate whether the VAS boards on Daventry Road can be reconfigured to show the speed that vehicles are travelling. The Clerk reported that trees are going to be cut back around the VAS near Barby School and Northants Highways are going to check it as it is not working.
13.5	It was reported that there are two electricity pylons leaning at an alarming angle on Cart Hill.
13.6	It was noted that the 7.5 tonne signage on the A45 has been split in half. This has been reported.
